#### B. Mandate

I/We acknowledge that all payment instructions issued by Rand Park High School shall be treated by my/our abovementioned Bank as if the instructions have been issued by me/us personally.

### C. Cancellation

I/We agree that although this Authority and Mandate may be cancelled by me/us, such cancellation will not cancel the Agreement. I/We shall not be entitled to any refund of amounts which you have withdrawn while this Authority was in force, if such amounts were legally owing to Rand Park High School.
