



## METHOD OF PAYMENT: 2025 SCHOOL FEES

Rand Park High School is a Section 21 Independent State School and therefore relies on parents paying fees as our main source of income. Public School fees are a statutory duty in terms of the South African Schools Act No. 84 of 1996. The cost of your child's education is the best investment you can make.

The school fees for 2025 approved at the AGM held on 23 October 2024 shall be: **R57,500 per existing learner** and **R59,000 per new learner**.

- School fees are due and payable annually in advance at the beginning of each school year and such payment is compulsory unless an exemption has been granted.
- However, purely in order to reduce the financial burden on parents, **TEN EQUAL** instalments commencing **January 2025** and ending **October 2025** will be acceptable. Any other payment arrangements must be approved, in writing, by the Finance Committee.
- Failure to pay **any single instalment** by the due date will mean that the **FULL** 2025 School Fee amount becomes due and payable **immediately**.
- The **first instalment paid** at the time of registration or any payment made **during the 2024 academic year** towards the 2025 School Fees **does not replace the January instalment. A further 10 equal instalments (January to October) are still payable.**
- A monthly payment from all parents is required. **No school fee account can lay dormant until a parent receives a bonus, SARS refund, UIF payout or any other third-party lump sum payout.**

3. **I/We are financially unable to pay school fees. I/We will collect the Exemption Application Form for partial exemption from the school office by 28 February 2025.**

Important notice:

- *If you wish to submit an exemption application, please note that you remain legally liable to pay school fees until such time as the exemption application has been received, reviewed and the outcome of such application has been communicated in writing.*
- *Parents who wish to apply for exemption should do so annually to the SGB. (Application forms will not be handed to any learner attending RPHS).*
- *The income of parents, guardians or caregivers (as defined in SASA), irrespective of their marital situation is used in the calculation of exemption.*
- *The SGB reserves the right to ask for any supporting documentation that they may deem necessary in assessing the exemption application.*

4. **ONCE-OFF ANNUAL PAYMENT:** 10% early settlement discount will be granted to those accounts settled in FULL by 31 January 2025.
